壹、學校簡介 Introduction

僑光於1964年創立，秉持校訓「明誠立信」，重視全人教育及商業倫理，為中部最具優良傳統的學校。歷年來商管、語文是僑光的發展主軸與強項，近年增加觀光、餐飲、設計等相關院系，並積極發展院系的重點特色，創造出優於他校的技職教育。

僑光未來不僅要維繫原有的聲譽與地位，並積極開拓兩岸與國際交流，拓展學生的視野，提升學生的專業技能，快樂學習輕鬆就業。

Overseas Chinese University (OCU), founded in 1964 with the motto “honesty, sincerity, righteousness, and trustworthiness,” values interdisciplinary education and business. In central Taiwan, OCU is a technological university with a tradition of excellence. Research and the application of business and languages have been the center of OCU's development and strength. Tourism, catering services, and design are its most recent specialty areas. The ultimate goal of OCU is to actively develop school features and become the best private university of technology.



貳、申請資格 Application Qualifications

一、外國學生身分(International Student Status)：

- (一) 具外國國籍且未曾具有中華民國國籍，並不具僑生資格者。

International students shall be defined as individuals who have never held Republic of China (Taiwan) nationality nor have had Overseas Chinese student status.

- (二) 具外國國籍且符合下列規定，於申請時並已連續居留海外六年(計算至2023年2月1日)以上者，得申請入學。

Individuals who hold foreign nationalities and have stayed abroad for more than 6 years (up to February 1, 2023) and who are qualified for one of the following situations are considered as international students.

1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

Individuals holding both foreign and R.O.C. nationalities but have never had household registration in Taiwan.

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至2023年2月1日)。

Individuals holding foreign nationality and once had R.O.C. nationality but his or her household registration had been revoked by the Ministry of Interior for at least 8 years (up to February 1, 2023)

3. 前兩款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。依教育合作協議，由外國政府、機關或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准者，不受此規定。

The above individuals who have never held Overseas Chinese student status or studied in Taiwan nor have received a student status by University Entrance Committee for Overseas Chinese in the enrollment year. Students who are recommended by foreign governments, organizations, or schools, according to educational cooperation agreements, are approved by the educational supervisory institutions, and have never held Republic of China (Taiwan) household registration.

- (三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得申請入學。

An applicant holding foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided in Hong Kong, Macao, or another foreign country (overseas) for no less than 6 years is qualified to apply for

admission under these regulations.

- (四) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得申請入學。

An applicant who is a former citizen of Mainland China, currently holds a foreign nationality, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided overseas for no less than 6 years is qualified to apply for admission under these regulations.

- (五) 上述所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾120日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾120日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” as prescribed in Paragraph 2 is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. The only 6 exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

1. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education.
2. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years.
3. 交換學生，其交換期間合計未滿二年。
Exchange students whose length of total exchange is less than 2 years.
4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。
An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

二、學歷：外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司網站)。

(Education): International students must have graduated from a senior high school, a university or independent college recognized by the Ministry of Education (Please refer to the website of the Department of International and Cross-Strait Education, Ministry of Education. <http://www.edu.tw/bicer/>). Applicants who

apply for this bachelor's degree must have a foreign senior high school diploma.

- (一) 具高中畢業資格以上者，得申請入學本校四年制修讀學士學位。

Students who graduated from high schools are eligible to apply for four-year undergraduate programs

- (二) 具學士學位以上者，得申請入學本校碩士班修讀碩士學位。

Students with bachelor degrees are eligible to apply for graduate studies in master's degree programs.

- (三) 具有教育部「入學大學同等學力認定標準」與我國學制相當之同等學力資格者。

The applicants has the qualification to be equivalent to the academic qualifications of Taiwan's academic system based on “Equivalent Education Level for University Admission” regulated by Ministry of Education.

- (四) 依教育部規定：英制教育(如緬甸緬文學校或菲律賓舊制教育)之學歷，其中學畢業年級僅相當於我國高中一年級，未能符合「大學辦理國外學歷採認辦法」，第 4 條所定「修業期限、修習課程，應與國內同級同類學校規定相當」之規定，爰學生所持國外學歷不得獲採認。

According to the Article 4 of MOE's “Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education”, the restrictions on the period spent undertaking a program, and the courses that must be completed shall be comparable to those prescribed for a comparable program at an educational institution in Taiwan of an equivalent academic level and nature. Students who have finished the secondary education under British Education System, which is equivalent to the first year of senior high school in Taiwan, are therefore not eligible for recognition.

參、申請方式(Application Method)

一、申請截止：2022年12月25日(日)前(春季班)

Application is due on December 25, 2022

四、申請應繳交資料 (Required Document Checklist)

(一) 繳交資料檢查表 Checking List (附表一)。

(二) 入學申請表一份(附貼二寸半身照片) Application Form (附表二)。

(三) 境外學校最高學歷或同等學歷證明文件及成績單。Certificates and transcripts of the highest degree or equivalent of the overseas school.

(四) 財力證明 Financial Statement：美金 2,000(2,000USD)以上之存款證明或獎助學金證明(請選擇以下任一種方式繳交)。

A financial statement or a copy of a scholarship award notification (Please select one of the following payment methods).

1. 最近三個月內，經金融機構以申請人名義開立足夠在臺就學之財力證明影本一份。

Photocopy of a financial statement that demonstrates financial sustainability for study in Taiwan (issued by a financial institution within the past three months).

2. 政府、民間機構提供全額獎助學金之證明。

Proof of full scholarship provided by a government agency, university, college or private organization.

※存款證明若由申請人的父母親名義開立，則必須再加附公證證明文件。

* If the financial statement is in the name of a parental guardian of the applicant, a public notarization of the financial guarantee is also required.

(六) 授權書一份 Letter of Authority (附表四)。

(七) 護照影本 Copy of Passport

(八) 個人身分證件(身分證或出生證明) Identification document

肆、其他申請注意事項 **Important Reminders**

一、申請人不曾以僑生身份在中華民國就讀。

Applicant has never studied in the ROC as an Overseas Chinese student.

二、外國學生申請來臺就學，以一次為限。

International students applying for schools in Taiwan shall be limited to one application only.

三、申請人入學前未具華語文能力 A2（含）級以上資格；入學後須於一年級下學期開學前通過華語文能力測驗 A2 級以上，未通過者將另參加華語文輔導課程。

Applicants, who do not obtain Chinese language proficiency A2 level or above before admission, must pass the Chinese language proficiency test A2 or above before the second semester of their first year. Those who do not pass will participate in the Chinese language tutoring course.

五、外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部（班）畢業者，得持該等學校畢業證書及歷年成績證明文件。

International students who have graduated from private high schools, lower grade schools for international residents in Taiwan, bilingual programs affiliated with senior high schools, or from a foreign curriculum department and classes at private senior high schools or below must submit credentials and transcripts for each academic semester to apply for admission.

六、依教育部規定，外國學生凡曾遭國內大專院校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再經由本管道申請入學。違反此規定並經查證屬實者，撤銷其所獲准入學資格。

International students who have been forced to withdraw from any educational institution in Taiwan are not allowed to apply for admission. Should any applicant be determined to have withdrawn from any educational institute in Taiwan, the applicant's student status will be revoked immediately.

七、為避免權益受損，入學申請表所填寫之資料應清楚無誤，否則因此無法通知而延誤時間或其他相關聯絡事項，其後果由學生自行負責。

All the submitted application information should be clear and without mistakes.

Applicants should be held fully responsible for any consequences arising from errors in application materials.

八、學生須自行檢查各項資料是否齊全，如有資料不齊全或因平信寄遞發生遺失而無法完成報名及延誤等情事，考生應自行負責。

Applicants should check all the required documents fully submitted to OCU. If any of the above required documents are incomplete or delayed by postal delivery, causing the

application to be incomplete, the applicants should be fully responsible for the consequences.

九、報名所填之各項資料及繳交證明文件，若與事實不符者，則取消其錄取及入學資格；入學後始被發現者，則依本校學則開除其學籍，亦不發給任何學歷證明；如將來在本校畢業後始發現者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

All the submitted application documents should be accurate and valid. If any of the above documents are found to be false, the applicant should be expelled and their diploma revoked if graduated.

捌、住宿及生活 Residence Fee & Living Expenses

一、住宿 Student dormitory

In order to be admitted to the dormitory, students must submit a health report. Each dormitory room houses 4 to 6 students

二、生活 Living Expenses (Exchange rate : USD : TWD \div 1 : 31)

(一)入學後所需辦理居留證、健康保險(如下)、體檢、銀行開戶等費用約8,000TWD(約260 USD)。

The fees for processing the Alien Resident Certificate (ARC), health insurance (see Notes 1.& 2.), physical examination and opening a bank account are approximately \$8,000 TWD (260 USD).

1. 入學六個月內需統一參加本校安排之投保6個月效期之醫療及傷害保險。
Students should accept the insurance arrangements made by OCU after registration.
2. 入學六個月後由本校統一辦理健保。
Six months after registration, students are required to have National Health Insurance.

(二)個人生活費(例如食物、交通及其他費用等)每個月不含娛樂及奢侈用品等約10,000 TWD (約 330 USD)。

The estimated living cost at OCU is about 10,000 TWD (330 USD) per month, including transportation and other personal expenses.

玖、附註 Remarks

一、入學許可並不保證簽證取得，簽證須由我國駐外館處核給。

Acceptance letters or admissions notices do not guarantee visa issuance. Visas are approved by the Ministry of Foreign Affairs.

二、經核准入學之外國學生，需持符合報考證明之各項文件正本經查驗無誤後始准註冊入學；各項證件如有偽造、變造、冒用、不實或利用錄取資格謀取不當利益等情事，一經查獲即開除學籍，不發給任何就讀有關證明，並應負法律責任。如於畢業後始被查獲者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

After being offered admission, students must prepare all documents and credentials that can prove their requirements for enrollment. If the documents or credentials students offer are found false, students will be dismissed from the school, will not be granted any school certificates, and will be held criminally responsible. If students are found offering false documents or credentials after they have graduated, their academic degree will be cancelled. School will publicly cancel students' requirements for graduation.

三、凡報名本招生者即表示同意授權本校依個人資料保護法規定，取得並保管考生個人資料，在辦理招生事務之目的下，進行處理及利用。本校將善盡善良保管人之義務與責任，妥善保管考生個人資料，僅提供招生相關工作目的使用。放榜時錄取生之個人姓名將會以全名顯示於榜單上，且錄取生資料將移轉至學籍管理單位使用。

Applicants, in accordance with the Personal Data Protection Law, will allow OCU to use their personal information for application and enrollment at OCU. OCU will keep applicants' personal information for the use of enrollment evaluation only. By submitting the application forms, applicants grant the school use of their personal information in aspects related to enrollment. Applicants' full names will be shown on the list of successful candidates. Their personal information will then be transferred to Registration.

四、依教育部規定，外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。

International students will lose their international student status and shall be expelled from OCU if they obtain Taiwan residency or Republic of China citizenship status during their course of study.

五、本簡章未規定事宜，悉依教育部外國學生來臺就學辦法、本校外國學生入學招生規定、教務章則及招生委員會決議辦理。

Any details not mentioned or regulated in this prospect must conform to the laws or policy of the Ministry of Education, Overseas Chinese University Admission Committee, and Overseas Chinese University Academic Affairs Division.

六、本簡章中文版與英譯版語意有所差異時，依中文版為主。

If there should be any discrepancy or contradiction, the Chinese version prevails.
