壹、申請資格 Application Qualifications

外國學生身分(International Student Status)

一、國籍 Nationality：

- (一)具外國國籍且未曾具有中華民國國籍，並未曾以僑生身份在臺就學，且未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

International students shall be defined as individuals who have never held Republic of China (Taiwan) nationality nor have had Overseas Chinese student status.

- (二)具外國國籍且符合下列規定，於申請時並已連續居留海外六年(計算至 2024 年 8 月 1 日)以上者，得申請入學。

Individuals who hold foreign nationalities and have stayed abroad for more than 6 years (up to August 1, 2024) and who are qualified for one of the following situations are considered as international students.

1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

Individuals holding both foreign and R.O.C. nationalities but have never had household registration in Taiwan.

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至 2024 年 8 月 1 日)。

Individuals holding foreign nationality and once had R.O.C. nationality but his or her household registration had been revoked by the Ministry of Interior for at least 8 years (up to August 1, 2024).

3. 前兩款均未曾以僑生身份在臺就學，且未於當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

The above individuals who have never held Overseas Chinese student status or studied in Taiwan nor have received a student status by University Entrance Committee for Overseas Chinese in the enrollment year.

依教育合作協議，由外國政府、機關或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准者，不受此規定。

Students who are recommended by foreign governments, organizations, or schools, according to educational cooperation agreements, are approved by the educational supervisory institutions, and have never held Republic of China (Taiwan) household registration.

- (三)上述所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” as prescribed in Paragraph b, c, and d is limited to countries or regions other than Mainland China, Hong Kong, and Macau. The phrase “continuously reside overseas” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the period of continuously living overseas does not conform to an academic year, the amount of time spent overseas shall be calculated as a maximum of 120 days. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supported proof:

1. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education.

2. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years.

3. 交換學生，其交換期間合計未滿二年。

Exchange students whose length of total exchange is less than 2 years.

4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

二、學歷：外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育國際及兩岸教育司網站)。

(Education):International students must have graduated from a senior high school, a university or independent college recognized by the Ministry of Education (Please refer to the website of the Department of International and Cross-Strait Education, Ministry of Education. <http://www.edu.tw/bicer/>). Applicants who apply for this bachelor's degree must have a foreign senior high school diploma.

- (一) 具高中畢業資格以上者，得申請入學本校四年制修讀學士學位。

Students who graduated from high schools are eligible to apply for four-year undergraduate programs.

- (二) 具有教育部「入學大學同等學力認定標準」與我國學制相當之同等學力資格者。

The applicants has the qualification to be equivalent to the academic qualifications of Taiwan's academic system based on “Equivalent Education Level for University Admission” regulated by Ministry of Education.

貳、申請方式(Application Method)

一、申請日期：2024 年 3 月 27 日(三)(秋季班)。

Application Deadline: March 27, 2024 (Fall semester).

三、繳交申請費：Application Fee: (We do not accept applications from those who do not pay the application fee.)

(九) 7月底前,須完成下列文件,以利辦理學生簽證,未如期完成者,其錄取資格將由備取完成者依序遞補。

By the end of July, the following documents must be submitted to facilitate the processing of student visas. Failure to provide these documents on time will result in the admission being filled by waitlisted applicants in sequential order.

Original and photocopy of passport: Valid for at least 6 months with blank pages.

2. 健康檢查合格證明

Certificate of passing a health examination.

Diploma and transcripts for each academic semester of the highest degree verified by the Philippine Department of Foreign Affairs (DFA).

4. 財力證明正本及影本(6 個月經常性財力)

Original and photocopy of financial statement (covering at least 6 months of study and living expenses).

5. 無犯罪紀錄證明：菲國國家調查局在 1 年內核發之無犯罪紀錄證明文件。
NBI Clearance: Document issued by the Philippine National Bureau of Investigation (NBI) within the last year.

6. 出生證明：持菲國護照者，請出具菲國人口出生統計局(PSA)核發之出生證明。

Birth certificate: For Philippine passport holders, please provide the birth certificate issued by the Philippine Statistics Authority (PSA).

7. 結婚證明：持菲國護照者倘為女性並已婚，請出具菲國人口出生統計局(PSA)核發之結婚證書。

Marriage certificate: For married female Philippine passport holders, please provide the marriage certificate issued by PSA.

參、其他申請注意事項 Important Reminders

- 一、申請人不曾以僑生身份在中華民國就讀。

Applicant has never studied in the ROC as an Overseas Chinese student.

- 二、外國學生申請來臺就學，以一次為限。

International students applying for schools in Taiwan shall be limited to one application only.

- 三、申請人入學前未具華語文能力 A2（含）級以上資格；入學後須於一年級下學期結束前通過華語文能力測驗 A2 級以上，未通過者將予以退學。

Applicants, who do not obtain Chinese language proficiency A2 level or above before admission, must pass the Chinese language proficiency test A2 or above before the end of first year, Those who do not pass they will be withdrawn.

- 四、外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部（班）畢業者，得持該等學校畢業證書及歷年成績證明文件。

International students who have graduated from private high schools, lower grade schools for international residents in Taiwan, bilingual programs affiliated with senior high schools, or from a foreign curriculum department and classes at private senior high schools or below must submit credentials and transcripts for each academic semester to apply for admission.

- 五、依教育部規定，外國學生凡曾遭國內大專院校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再經由本管道申請入學。違反此規定並經查證屬實者，撤銷其所獲准入學資格。

International students who have been forced to withdraw from any educational institution in Taiwan are not allowed to apply for admission. Should any applicant be determined to have withdrawn from any educational institute in Taiwan, the

applicant's student status will be revoked immediately.

- 六、為避免權益受損，入學申請表所填寫之資料應清楚無誤，否則因此無法通知而延誤時間或其他相關聯絡事項，其後果由學生自行負責。

All the submitted application information should be clear and without mistakes. Applicants should be held fully responsible for any consequences arising from errors in application materials.

- 七、學生須自行檢查各項資料是否齊全，如有資料不齊全或因平信寄遞發生遺失而無法完成報名及延誤等情事，考生應自行負責。

Applicants should check all the required documents fully submitted to OCU. If any of the above required documents are incomplete or delayed by postal delivery, causing the application to be incomplete, the applicants should be fully responsible for the consequences.

- 八、報名所填之各項資料及繳交證明文件，若與事實不符者，則取消其錄取及入學資格；入學後始被發現者，則依本校學則開除其學籍，亦不發給任何學歷證明；如將來在本校畢業後始發現者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

All the submitted application documents should be accurate and valid. If any of the above documents are found to be false, the applicant should be expelled and their diploma revoked if graduated.

陸、申訴辦法 The Appeal Process

- 一、申請人如對招生事宜有疑義或申訴試務過程違反性別平等原則(含性別、性別特質、性別認同或性傾向之差別待遇)，應於放榜後二週內，向本校招生委員會提出申請。

If the applicants have any concerns about admission matters or believes that there have

been a violation of gender equality principles during the admission process (including gender, gender characteristics, gender identity, or sexual orientation discrimination), they should file a complaint with the school's Admissions Committee within two weeks of the release of results.

- 二、申請人申訴書應以正式書面詳載姓名、申請所系、聯絡電話、日期、申訴之事實及理由、希望獲得之補救及檢附有關文件或證據。

The complainant should submit a formal written complaint including their name, department of application, contact phone number, date, the facts and reasons for the complaint, the desired remedy, and attach any relevant documents or evidence.

- 三、申請人申訴案，如有下列情形者不予受理：Complaints will not be accepted under the following circumstances:

(一)招生有關法令或招生簡章已有明確規範者。

When there are already clear regulations in the relevant laws or admission brochures.

(二)逾申訴期限。

If the complaint is submitted after the specified deadline.

(三)未具名之申訴案件。

Complaints submitted without a valid name.

- 四、受理之申訴案，由本校招生委員會組成之申請人申訴處理小組處理之。必要時，得通知申訴人或關係人列席說明。

Accepted complaint cases will be handled by a Complaint Handling Team composed of members of the school's Admissions Committee. If necessary, the complainant or relevant individuals may be invited to attend and provide explanations.

- 五、申訴以一次為限，申訴處理結果由招生委員會於一個月內函覆申訴人。

Each complainant is limited to one complaint, and the results of the complaint handling will be communicated to the complainant by the Admissions Committee within one month.

一、入學許可並不保證簽證取得，簽證須由我國駐外館處核給。

Acceptance letters or admissions notices do not guarantee visa issuance. Visas are approved by the Ministry of Foreign Affairs.

二、經核准入學之外國學生，需持符合報考證明之各項文件正本經查驗無誤後始准註冊入學；各項證件如有偽造、變造、冒用、不實或利用錄取資格謀取不當利益等情事，一經查獲即開除學籍，不發給任何就讀有關證明，並應負法律責任。如於畢業後始被查獲者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

After being offered admission, students must prepare all documents and credentials that can prove their requirements for enrollment. If the documents or credentials students offer are found false, students will be dismissed from the school, will not be granted any school certificates, and will be held criminally responsible. If students are found offering false documents or credentials after they have graduated, their academic degree will be cancelled. School will publicly cancel students' requirements for graduation.

三、入學六個月內需統一參加本校安排之投保 6 個月效期之醫療及傷害保險。

Students should accept the insurance arrangements made by OCU after registration.

四、凡報名本招生者即表示同意授權本校依個人資料保護法規定，取得並保管考生個人資料，在辦理招生事務之目的下，進行處理及利用。本校將善盡善良保管人之義務與責任，妥善保管考生個人資料，僅提供招生相關工作目的使用。放榜時錄取生之個人姓名將會以全名顯示於榜單上，且錄取生資料將移轉至學籍管理單位使用。

Applicants, in accordance with the Personal Data Protection Law, will allow OCU to use their personal information for application and enrollment at OCU. OCU will keep applicants' personal information for the use of enrollment evaluation only. By submitting the application forms, applicants grant the school use of their personal information in aspects related to enrollment. Applicants' full names will be shown on the list of successful candidates. Their personal information will then be transferred to Registration.

五、依教育部規定，外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。

International students will lose their international student status and shall be expelled from OCU if they obtain Taiwan residency or Republic of China citizenship status during their course of study.

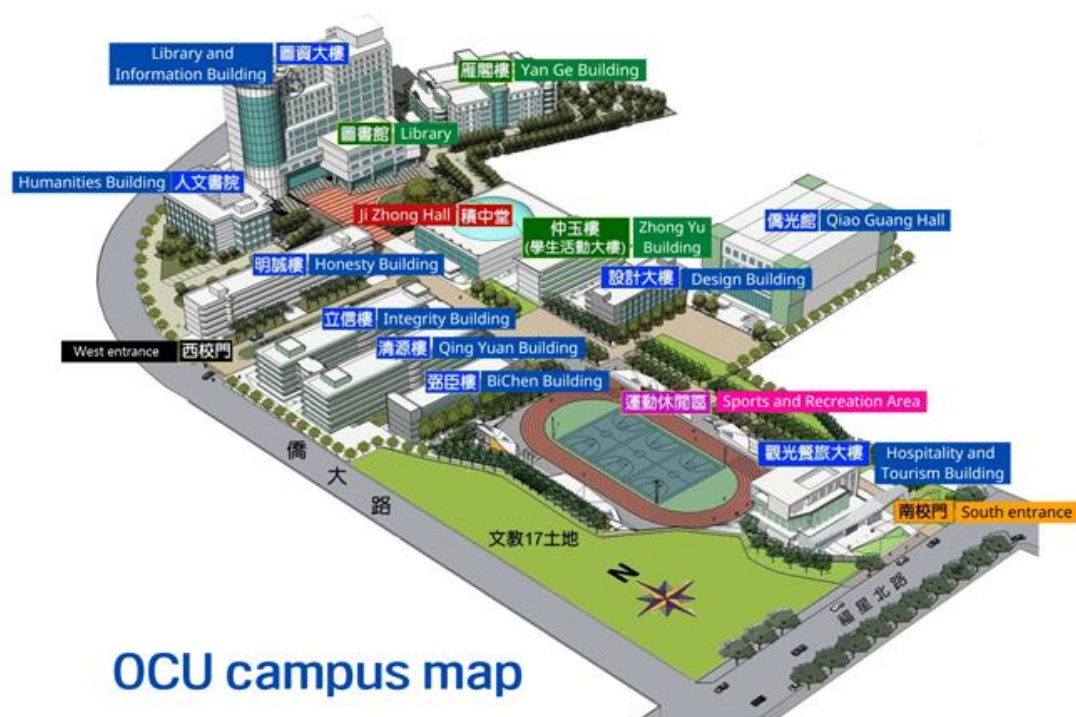
